Impermanence can be very difficult for us to accept. Yet, there is nothing in this world that does not experience impermanence. Even the most solid appearing mountain range is changing moment by moment. Everything in the world, experiences this change. Sometimes in an obvious way, and sometimes it is very subtle and not so easy to recognise. But the change is still occurring.

The oldest of institutions shift and change. Buildings and roads change. Society's values change. Beliefs change. The clouds in the sky change. Thoughts and feelings change. Even the sun and moon that rise and go down every single day are changing moment by moment. The list of things that experience change is endless.

But the most obvious and yet often the most difficult for us to accept is how we, and those we love, change. Whether externally in relation to our body, or internally, in relation to our mind. But change we do. We age, we get sick, we change our ideas and views, and we die. Enemies become friends, friends become enemies and those enemies become friends again. But we often create a deep and lasting barrier and aversion to this change that only serves to create suffering for ourselves and often for others.

Believing what is impermanent to be permanent can only create expectations that are impossible to be realised.

However, acceptance of impermanence allows us the space, clarity, flexibility, and wisdom to influence and change what we can. It also offers us the compassion and generosity of spirit to let go of trying to control what we cannot change at any particular moment in time. This reduces the propensity to engage with so many of the troubling thoughts and feelings that arise about things we can't influence, whilst at the same time recognising that at some point in the future change might again be possible when different conditions arise.

The key is not to grasp tightly to either possibility, rather to just allow them to sit lightly like a feather resting in the palm of our hand. Accepting impermanence offers us agency, capacity, understanding and awareness. It helps us to develop our compassion, kindness, patience, perseverance, love and wisdom both for ourselves and for others. Accepting impermanence is proactive and can deepen our commitment to living our life well in each moment, irrespective of what that life is offering us. It offers us the opportunity to be in the present, to appreciate simplicity and is a reminder that in every moment the inevitability of change exists, no matter how hard we might try and control it.

## **CEO** Report

It is a pleasure to share this reflection and review of Karuna's work and progress this 2022-2023 financial year. Karuna has emerged stronger and surer of our place in the community services sector.

Notwithstanding the challenges of regrouping post the longer-term effects of the pandemic, I am proud of the whole teams' resilience and dedication to serving our community.

This financial year has been one of consolidation and growth. Our team has grown to include professionals in their field who bring a breadth of skills and experiences to our service delivery that has complemented our model of care. Working alongside our long-term team members has been a pleasure to watch, as the teams unite in their common goal.

This financial year concluded with an operational surplus due in no small part to our collective approach to diligence and efficiency. Our approach to this surplus is to reinvest this into activity that supports growth and sustainability initiatives resources. We also believe that it demonstrates to our supporters and funders, that Karuna is well-managed and governed by a professional Board and Leadership team. The surplus also allows us to support people diagnosed with life limiting illnesses who may not qualify for government funded or

private health fund services. We can allocate resources to people who find themselves in unfortunate circumstances, in need of care and support.

As a service provider, it is essential to ensure we have the right people in the right roles. Our focus is on a 'one team' approach designed to facilitate communication and understanding amongst all facets of Karuna's operation. Therefore, it is essential our work culture enables teams to work collaboratively and with purpose. We have invested in building our skills mix internally and focused on 'people and culture'.

Fundraising and community engagement activity has seen some new and diverse approaches. The generosity and loyalty of our supporters has been key to achieving the outcomes we have this financial year. During the year we undertook to nurture new ideas and people in our community engagement activities, building new relationships that have yielded positive results. One example being that we were pleased to have been able to return to supporting the community in the Moreton Bay region.

As part of our broader awareness building activity, we focused on engaging with even more people in the community to ensure they understood the benefits, both fiscal and emotional, of personalised palliative care in place.

This has been especially important during times of economic hardship, and the natural disasters to have impacted the community. We saw the emergence of how increases in the cost of living were having an adverse impact on families and the community at large. At a time when receiving the news of a life limiting illness and all the emotional and financial implications that come with this, Karuna's 24/7, no fee service for care and support at home becomes an even more powerful reason to support this service.

## Community Services

Once again, our exceptional Community
Services team demonstrated the gold standard
of palliative care in place of choice. Karuna's
unique fusion of compassionate care, clinical
practice and allied health, supported by a sound
corporate structure was demonstrated in the
delivery of services and then acknowledged in
the many letters of gratitude and financial
support we received from our families.

Changes in the general community services environment ensured we kept a keen eye on understanding how they would affect Karuna. These changes included regulatory and legislative changes, such as the Voluntary Assisted Dying (VAD) legislation. With the introduction of VAD we implemented changes to our clinical protocols and introduced education to the community services team to ensure correct protocols were in place and enacted. It was equally important that patients knew we would respect their choices should they chose to consider this option and that we would continue to care for them.

Despite the changes Karuna has been able to not only adapt, but thrive during this financial year, whilst maintaining the traditional values underpinning our service delivery model. These changes have served to augment our service delivery model and enabled everyone to rally together to address the changes as a team.

#### 'Live well, die peacefully'.

Our motto is what motivates us and informs how we offer personalised care, tailored to the individual patient's needs and preferences. Karuna is well-known for our patient-centered and holistic approach to care.

We have welcomed the new perspective around the economic benefits of home-based palliative care which is better understood and supported by our government and other stakeholders.

Services such as Karuna have the skills and knowledge to actively support reduction in hospital readmissions. With the continuity of care our service offers, patients are better equipped to manage their symptoms and avoid unnecessary emergency room visits. Further, home-based services are cost-effective compared to extended hospital stays or frequent emergency room visits. This in turn can reduce healthcare costs by preventing unnecessary interventions.

Looking ahead, our vision is to enhance our model of care and grow the influence of Karuna and our mission, such that more people in need of end-of-life care may seek our support.

Our goal is to support more diverse groups in the community who we know will benefit from our care, and to incorporate innovation into our service delivery model, through technology to support that vision. We seek engagement with technology that compliments (not replaces) engagement with patients and families. The value of the face-to-face approach for which Karuna is known can never be replaced. Exploring options in remote patient monitoring platforms offers potential to offer support to communities with limited or no specialist resources.

We also look forward to working closely with our peers in the community service network and exploring new opportunities to share our wealth of knowledge and experience.

## Spiritual care update

#### Spiritual care at Karuna

As the Spiritual Care Practitioner and Counsellor at Karuna, it is a great privilege to be able to support our families as they navigate their way through a life limiting diagnosis and the subsequent end of life.

As a Buddhist based organisation that is focused on person driven care, our philosophy is to share this experience with our families and to support them in whatever way they need, to find that peace of mind and heart during a time that can often bring many different challenges, difficulties, and anxieties. We support people of all faiths, beliefs, and those with no belief system at all. We simply provide human to human, heart to heart care.

Buddhism, although often labelled a religion, is in fact, a science of the mind. It offers us knowledge, tools, and techniques to engage with our life and our world with compassion and wisdom. One doesn't need to be a Buddhist to practice some of the teachings and techniques of our historical buddha, Buddha Shakyamuni, and the many highly qualified and realised teachers that have followed in his footsteps for more than 2,500 years.

#### **Buddhist principles and teachings**

Buddhism has a profound, yet very logical perspective of the mind. It explains that as human beings, due to our intelligence and our capacity to investigate, reflect, and act, we are in a unique

position to consciously, and intentionally, develop an understanding and practice of qualities such as equanimity, loving kindness, compassion, and wisdom.

Through study, contemplation, and meditation we can learn to understand how the mind affects every aspect of how we perceive and respond to our world. It teaches how we can develop knowledge and cultivate qualities and skills that we can use every day in every situation, to reduce and ultimately eliminate our suffering and to abandon those things that are obstacles to that freedom. And it teaches us to be aware of the suffering of others, not in order to feel despair or helplessness, but as a means to develop a deep compassion and wisdom.

Anyone can use the teachings of the Buddha to find happiness and to be free of suffering in this life and in future lives, and individuals can choose to what extent they wish to learn and practice those teachings. The Dalai Lama has often expounded that those of other faiths and beliefs can if they wish, utilise certain aspects of Buddhism to strengthen and enhance their own faith and practices.

#### **Buddhist principles in palliative care**

The principles of Buddhism help to support and care collaboratively with our families in a way that offers an understanding that life and death are intimate partners and not opposites. There is power in our mind and in our heart that we can access, even if we feel we have lost control and fear what might come. Love, is a basis for this power and is an unlimited resource accessible to us all, even if we think that's not possible.






#### **Home Care Admissions**

2022-23: New admissions = 178









#### **Outcomes of care**


Median across 2021-22 and 2022-23



#### **Diagnosis**




#### After hours care

The Operations team provides essential support to the entire team at Karuna, including fleet management, information management and technology; health, safety and quality; facilities/equipment management and logistics.

COVID-19 positively influenced and accelerated many changes across Karuna. This included the opportunity to review all our organisational policies and procedures. During an evolving situation, our staff adapted well as we pivoted towards predominantly work remotely and mobile. This was particularly important as we needed to protect our frontline staff who were still engaging in community visits.

Our dear Rosemount House required some tender loving care throughout the year – given her history which dates back to the 1850s! We undertook to replace the roof insulation and our garden was given a lovely refresh.

As with most organisations, cyber security and privacy is always a high priority for Karuna. Therefore several systems have been implemented to help maintain safety across our online infrastructure including authentication processes, secure email systems, cloud-based software and regular education and training for our staff. The safety of our staff is paramount. We have taken additional steps to enhance our safety measures by implementing personal safety alarms (specifically for our frontline staff who do home visits everyday) and have also increased the presence of CCTV across the Karuna House grounds.

## Investment Advisory Committee

Karuna's investment portfolio has continued to grow and we thank our friends at Morgans for their support in making this happen.

The portfolio was established in 2020 to invest in assets that would yield a return that supports our organisation's operations, along with activity to support growth and sustainability.

This financial year the Investment Advisory Committee undertook a review of the portfolio and drafted a comprehensive Investment Advisory Policy to update our governance and investment guidelines. We established a number of objectives aligned with Karuna's strategic focus areas, values, mission and purpose, all informed by the Buddhist philosophy that underpins all of this. We are also focusing on investments that demonstrate a strong commitment to Environmental, Social and Governance ('ESG') principles.

Our ongoing goal is to position our portfolio firmly with a sustainable investing spectrum, whilst maintaining market rate returns, avoiding harm and benefiting people and the planet.

## Clinical Governance Advisory Committee

It is important that a nationally consistent approach in applying clinical governance and quality improvement is embedded into Karuna's clinical practice. This governing body has oversight for ensuring the organisation is run well and delivers safe, high-quality care.

The Committee does this by establishing a strong safety culture through an effective clinical governance system, satisfying itself that this system operates effectively, and ensuring that there is an ongoing focus on quality improvement. Implementation of an organisation's clinical governance system involves contributions by individuals and teams at all levels of the organisation.

#### Karuna Hospice Service Clinical Governance Committee aims and objectives:

- Support alignment to best practice guidelines and standards.
- Monitor the quality, safety, and efficacy of clinical services.
- Assist with risk profiling of clinical services.
- Foster research and collaboration opportunities.
- Engage stakeholders through promotion and advocacy of clinical services.
- Ensure value and vision of Karuna are maintained within care delivery and clinical structure.

## Financial Overview

In the 2023 Financial Year, Karuna received \$3.3 million in funding and achieved a net surplus of \$509K.

Along with the ongoing confidence of Queensland Health to continue to support our mission, this surplus is due in no small measure to the kindness and generosity of our supporters and the careful management of our investment portfolio.

Our investment portfolio grew in the 2021-2022 Financial Year with gifts in Will and generous major gifts received. This has established an excellent foundation from which we have been able to continue to grow our investment portfolio in the 2023-24 Financial Year.

The portfolio will contribute to Karuna's future as a sustainable and resilient organisation, as well as ensuring we continue to support our clients and their families through the challenging economic time.

Furthermore, the strategic projects and innovations will be funded by the investment portfolio to ensure the organisations' continuous growth into the future.
